## Wholesale BAU Meeting 18<sup>th</sup> November 2010

Marilyn Morris (Accord President) and PEC member Kate Davidson were joined by Adam Adnyana (Accord Officer) for the latest BAU Consultation meeting. Amongst the company representatives we welcomed Diane Sheret and Sue Dryden from Wholesale ER.

Paul Gordon (Change & Integration Director) provided an overview of the 3 phase Wholesale Integration Programme. The majority of Phase 1 which relates to the Organisational Design and Re-structuring has progressed and is completed. Significant progress has also been made on Phase 2 which is the harmonisation of brands and bringing together of the Risk Framework and Property Portfolio. Phase 3, which is running in parallel, relates to the migration to target systems and migration of customer accounts. Further updates will be provided as the Programme continues into 2011.

The next meeting will be held in January 2011. BAU meetings are one form of consultation between Accord and the Bank.
